#### **RECOMMENDED ACTION:**

**RECEIVE** information on the status of US Bicycle Route 95 in Monterey County and in California and **PROVIDE INPUT** on route alignment.

#### SUMMARY:

US Bicycle Route 95 is a national bike route that follows the coast of California through the states of Washington and Oregon to the north. In order to designate a US Bicycle Route, each local road owner needs to communicate to Caltrans that they support the route. The Cities of Monterey and Sand City have already expressed their support of the route to Caltrans. Among the 70 local agencies along the route in California, 43 have approved the designation.

#### FINANCIAL IMPACT:

There are no costs associated with US Bicycle Route designation. Signage is not required and there are no engineering, design, or maintenance standards that must be met.

#### **DISCUSSION:**

In 2008, the American Association of State Highway and Transportation Officials established a nation-wide corridor plan for US Bicycle Routes to facilitate travel between the states on roadways identified as suitable for cycling. US Bicycle Routes traverse a majority of roads and streets, with some connections on separated trails when appropriate.

State Departments of Transportation, such as Caltrans, determine the suitability of a route for a US Bicycle Route and submit an application to the American Association of State Highway and Transportation Officials for the official designation as a US Bicycle Route. There is no requirement for facility construction or upgrades to routes identified as a US Bicycle Route. When submitting the request for designation, State Departments of Transportation must confirm that all relevant jurisdictions support the proposed route through local resolutions.

The Adventure Cycling Association houses many relevant resources to guide the route implementation process, including reference to the American Association of State Highway and Transportation Officials Purpose and Policy document (**web attachment**). Adventure Cycling Association also promotes the environmental, economic, health and transportation benefits of establishing a US Bicycle Route.

Adventure Cycling Association has identified a handful of clarifications for questions that have arisen in establishing a US Bicycle Route:

• The target audience for US Bicycle Routes are long-distance bicycle travelers who are experienced road users

and accustomed to riding in higher-density traffic and at higher speeds.

- There is no cost for implementing a US Bicycle Route and there is no requirement for signage. Routes can be designated through a number of ways, including: maps, signs, pavement markings, downloadable geographic coordinates, etc.
- The roads, streets and trails designated as US Bicycle Routes are not limited in any way from being changed.
- Local jurisdictions are encouraged to submit alternative alignments to Caltrans if they desire.



#### **RECOMMENDED ACTION:**

**RECEIVE** update on Bicycle Secure Program and **RECOMMEND** approval of the revised, rolling program for Agency Board approval.

#### SUMMARY:

The Bicycle Secure Program improves the infrastructure needed to support increased use of bicycles, skateboards and scooters. While historically operating as a traditional grant cycle, staff is advising the transition of the program to an on-going, rolling program to allow the Agency to accept applications until the budget has been expended.

#### **FINANCIAL IMPACT:**

The Transportation Agency's FY 19/20 budget has \$30,000 in Regional Surface Transportation Program funds designation for the Bicycle Secure Program. Historically, there has been a surplus of funds following the closure of the grant cycle and the Executive Director has been granted authorization to allocate surplus funds to additional applications later in the calendar year.

#### **DISCUSSION:**

Studies have shown that one of the primary reasons that individuals do not travel via bicycle is the lack of a secure place to store their vehicle. The Bicycle Secure Program addresses this need by funding bicycle racks and bicycle shelters. Over time, the program has been expanded to include other facilities to support active transportation such as bicycle repair stations and skateboard racks. The program serves the Agency's public mandate to achieve a coordinated and balanced regional transportation system by promoting active transportation. By providing secure bicycle parking, businesses can attract more bicycle-riding patrons, employers can support the growing number of people who choose to bicycle to work, and schools can support students who bike to school - all of which supports local economic, health, and environmental goals.

Specific program goals include:

- Increasing the amount of secure bicycle parking in Monterey County giving high priority to locations without existing bicycle parking.
- Ensuring equitable distribution of bicycle parking facilities across Monterey County.
- Providing bicycle parking in convenient locations to encourage bicycling.
- Supporting artistic design of facilities that increase visibility of bicycle parking and maintain the character of a special area or district.

Recipients of 2019 program included: City of Monterey, Salinas Regional Sports Authority, Monterey County Fair &

Events Center, and Active Seniors Inc. in Salinas.

During the 2019 grant cycle, \$8,417.37 was expended on bicycle facilities. Salinas Valley Memorial Hospital applied to the 2019 program, but decided to reapply for their bicycle racks at a later cycle of the grant program.

Transitioning to a on-going, rolling grant program would allow staff to continually accept applications until the budget is expended over the course of each year. Maintaining a on-going grant program would create flexibility in the application process and broaden the timeline for organizations to apply to the program.

Under the on-going program, the budget would reset at the beginning of each fiscal year (July 1st through June 30th), dependent upon the adopted Agency budget. Staff will continue to bring a recommendation to the Bicycle and Pedestrian Facilities Advisory Committee for approval of applications. #### **RECOMMENDED ACTION:**

**NOMINATE** up to three members of the Bicycle and Pedestrian Facilities Advisory Committee to serve on the TAMC Competitive Grant Application Review Committee.

#### SUMMARY:

The Transportation Agency Board approved a new cycle of competitive grants at its March 2020 meeting. The grant applications for projects proposed for funding are due June 1, 2020. Agency staff is seeking to establish an ad hoc committee to review and rank the applications, and provide funding recommendations.

#### **FINANCIAL IMPACT:**

The three-year estimated funding of Regional Surface Transportation Program is \$3.6 million for fair share and up to \$12.2 million for the competitive program. The \$12.2 million includes \$9.36 million of new Regional Surface Transportation Program funds, \$750,000 of new Transportation Development Act 2% for bicycle and pedestrian project funds, and up to \$2.1 million unexpended from the last competitive grants cycle. The deadline for billing to the prior year cycle is three years after approval of the grants, or August 31, 2020.

#### **DISCUSSION:**

The Surface Transportation Block Grant Program is a federal program that provides states and local jurisdictions with funding for highway improvements, street rehabilitation and transportation enhancements. The Transportation Agency receives an annual apportionment of Regional Surface Transportation Program funding, passed through the State. Because Monterey County didn't have an urbanized area with a population of greater than 200,000 in the 1990 census, it qualified for the state exchange program, whereby Caltrans keeps the federal Surface Transportation Block Grant Program apportionments for a region and gives the regional agency an equivalent amount of state cash.

The Transportation Agency distributes Regional Surface Transportation Program funding in both fair-share and competitive programs. Monterey County and the cities receive fair-share Regional Surface Transportation Program funds based on a formula of 50% population and 50% centerline miles. The total fair share allocation over the next three years is \$3.6 million.

The Transportation Agency distributes the remaining portion of the Regional Surface Transportation Program funding on a competitive basis to transportation projects based on a variety of criteria, including safety, traffic volume and project readiness. The competitive grants process starts with a call for projects, which was approved by the Transportation Agency Board at the March 2020 meeting, and the release of grant application materials. With the grant application deadline set at June 1, 2020, staff is seeking to establish an ad hoc committee made up of members of the Bicycle & Pedestrian Committee, Technical Advisory Committee, partner agencies, and Transportation Agency staff to review and rank the applications, and provide funding recommendations. Staff is requesting that at the meeting the Committee nominate up to three members for the grants review committee.
