## 1. WELCOME

Theresa Wright, TAMC outreach coordinator, called the meeting to order at 2:00 p.m. She welcomed the committee, self-introductions were made and the group convened outside to take a group photo.

### 2. REVIEW COMMITTEE PURPOSE & RESPONSIBILITIES

Debbie Hale, Executive Director of TAMC, provided an overview of the committee's purpose and responsibilities as outlined in the "Policies & Project Descriptions" for the Transportation Safety and Investment Plan.

### 3. REVIEW BROWN ACT REQUIREMENTS

Kay Reimann, TAMC's legal counsel, reviewed Brown Act requirements with the committee and their role in adhering to these requirements as members of the X-TOC committee. Several questions followed her presentation which included what impact the recent legal ruling about personal devices being subject to "public information" requests if they are used for work purposes.

### 4. REVIEW TRANSPORTATION SAFETY & INVESTMENT PLAN

Ms. Wright reviewed the Transportation Safety & Investment Plan approved by voters on November 8, 2016. The review included a description of each project and revenue distribution formula identified in the plan.

### 5. REVIEW LOCAL FUNDING FOR INVESTMENT PLAN

Todd Muck, Deputy Director of TAMC, discussed the Measure X funding for local jurisdictions and what tax revenue funds from Measure X could be spent on.

#### 6. <u>PUBLIC COMMENTS</u>

None.

### 7. ELECTION OF CHAIR AND VICE CHAIR

Ms. Wright called for nominations for a committee Chair and Vice Chair. Cesar Lara nominated himself to serve as Vice Chair. Receiving no other nominations, the committee unanimously voted Mr. Lara to be Vice Chair. Committee members nominated Paula Geiselman and Kevin Dayton to serve as Committee Chair. With a 9-7 vote, the committee approved the nomination of Kevin Dayton. The meeting was then turned over to Committee Chair Dayton.

#### 8. ANNOUNCEMENTS AND/OR COMMENTS

Chair Dayton called for announcements and/or comments. Committee members requested if all representatives and alternates could attend each meeting. They felt it was important to have everyone attend since this is a quarterly meeting. Agency staff and counsel said there was no reason not for them to attend and the group could decide. After discussion, members agreed that that each representative and alternate should attend future meetings, instead of the current proposal of having alternates attend only if their representative was not able to.

Chair Dayton asked if the committee's bylaws were available for their review. Ms. Reimann explained that the bylaws were being presented to the TAMC Board on April 26, 2017. Ms. Wright agreed to email copies of the bylaws to committee members after the board meeting. Chair Dayton asked committee members to review the bylaws when they received them. He also requested that the bylaws be placed on the agenda of the next meeting for further discussion.

Other items suggested for the next meeting's agenda are:

- o A draft of the strategic expenditure plan
- Maintenance of effort
- o The role of subcommittees.

### Other comment/questions:

- How are you going to account for the County maintenance of effort in light of all of the road damage with the storms?
- Will the local agreements be in place before local jurisdictions get their funds? Are the projects listed in the Investment Plan by the cities/county "suggested" projects or can they be changed? Does the committee have oversight over what projects the cities/county will fund through the plan?
- o Ms. Hale explained that the committee's role was to make sure tax dollars are properly used. That the money is used wisely and accounted for. Mr. Muck went on to say that the projects identified in the plan were suggested projects and that the committee did not have oversight over what projects the cities selected, but they did have oversight over whether the money was used on a transportation project has defined under the terms of the Policies & Project Description for the Transportation Safety & Investment Plan.
- Member Bumba asked what ramifications will the \$52 billion state transportation bill have on Monterey County and how does it relate to Measure X?
- o Mr. Muck responded that the purpose of the bill was to get more roads repaired. He further explained that the agency role is "go after the money and bring it back to Monterey County." He said some of this money would be available through competitive grants for safety programs, which would be helpful to the cities/county. Director Hale pointed out that Monterey County had over a billion dollars' worth of maintenance needs and that any additional amount will allow us to do more roads repairs, but there is still a lot of need.
- Member Rowley suggested that Monterey County should advocate for one of its state elected officials serve on transportation committees in Sacramento. He noted that it has been decades since a local official served in this capacity.
- o Member asked who their point of contact was if they had questions?
- o Ms. Hale replied that Ms. Wright was the person to contact.
- o Ms. Wright announced that the next meeting will be held on Tuesday, July 18<sup>th</sup> at 2:00 p.m. She said that she will confirm the location and send out a notice to committee members.

## 9. ADJOURNMENT

Chair Dayton adjourned the meeting at 3:30 p.m.

## 1. <u>WELCOME</u>

Kevin Dayton, Committee Chair, called the meeting to order at 2:00 p.m. He welcomed the committee and proceed to take roll call. Committee member Victoria Beach call in on the free conference call in number to participate in the meeting. During the roll call, it was noted that a correction was needed to show that the alternate habitat preservation representative is Sarah Hardgrave and not Rita Dalessio as listed.

After the roll call, Chair Dayton asked for self-introductions from those in attendance. After introducing herself, Theresa Wright, TAMC's community outreach coordinator, announced that the Agency had received a nomination from Communities for Sustainable Monterey County for Heidi Zamzov to serve on the committee as a pedestrian representative. She went on to say that the TAMC Board would receive Heidi's nomination for the appointment to serve on the committee on August 23<sup>rd</sup>. She then invited Heidi, who was attending the meeting as a member of the public to introduce herself. Chair Dayton, then asked if there were any other open position on the committee. Ms. Wright said there were alternate representative positions open for the categories:

- youth/college
- pedestrian
- Latino organization
- transit users alternate

Vice-Chair Cesar Lara announced that Healthy Communities had hired a Land Use Coordinator, who is designated to serve as their alternate. He agreed to provide that person's name so that Ms. Wright could include it in her staff report for the August TAMC Board meeting.

## 2. RECEIVE UPDATE ON THE MEASURE X STRATEGIC EXPENDITURE PLAN

Mike Zeller, Principal Transportation Planner for TAMC, provided a comprehensive update on the Agency's efforts to adopt a Strategic Plan that prioritized the regional projects and establishes a timeline for their implementation within twelve months of the sales tax taking effect. Mr. Zeller explained that the primary purposes of the Strategic Plan are to:

- Define the preliminary scope, cost and schedule for the regional projects in Measure X;
- Forecast Measure X and matching fund revenue streams and identify possible financing tools needed to deliver the regional program;
- Prioritize regional projects and define a schedule for delivery of those projects spread out over 30 years to match cash flows and potential debt financing obligations;
- Identify sources of matching and leveraged funds for regional projects;
- Identify critical issues and risks to program delivery;
- Identify a lead implementation agency or "project sponsor" for each regional project;
- Layout a year by year implementation schedule and cash flow; and,
- Gather into one document the policies and procedures adopted to implement the Measure X Strategic Plan.

The Strategic Plan is a 5-year programming document. It provides a snapshot of anticipated cash flow, as well as a commitment of funds to specific projects for the next five years of Measure X. In order to effectively reflect upon actual revenues and project progression, Agency staff is proposing to update the Plan every two years.

After a robust discussion, Vice Chair Lara asked if the committee could schedule a study session to review the final draft plan before it goes to the TAMC Board for approval in October. It was recommended that the committee work with Ms. Wright to set up another meeting in September for that purpose.

## 3. RECEIVE AN UPDATE ON THE SR 68 SCENIC HIGHWAY PLAN

Grant Leonard, TAMC's Transportation Planner, presented an update on the SR 68 Scenic Highway Plan. The outcome of this plan will help determine how best to leverage the \$50 million dollars in Measure X funds designated to make improvements on the highway approved by voters in the Transportation Safety & Investment Plan.

Mr. Leonard explained that in 2015, the Agency received a California Department of Transportation (Caltrans) Sustainable Communities Planning Grant to evaluate current and future travel patterns between Salinas and the Monterey Peninsula, the feasibility of affordable mid-term operational and capacity improvements in the SR 68 corridor in context to other planned regional improvements, and the potential for wildlife connectivity enhancements

He said that for more than a year, the Agency with a team of consultants has conducted extensive public outreach plan to determine what the public viewed as the most critical needs for the corridor. The outreach included a public workshop, meetings with local jurisdictions and stakeholder groups, and an interactive online forum for people to provide comments. The Agency also conducted numerous transportation studies to develop three concepts designed to improve the reliability of the highway that reflected the public's input and the outcomes from the transportation studies and recommendation for wildlife connectivity enhancements.

The three corridor alternatives presented at the April 26, 2017 TAMC Board meeting were:

- Concept 1: Installation of roundabouts at major intersections
- Concept 2: Selective segment widening with roundabouts at major intersections
- Concept 3: Integrated corridor management (adaptive signalization) with some widening

Mr. Leonard explained that since the April Board meeting, the project team has been engaged in a second phase of public outreach to gather public input on the three alternatives. Some of the key findings of the outreach include:

- Strong support for roundabouts in general and for Highway 68
- Support for keeping Highway 68 a scenic roadway
- Strong opinions for and against widening Highway 68 to four lanes
- A lack of support for Alternative 3

He went on to say that this public feedback was used to help inform final recommendations for the SR 68 Scenic Highway Plan. At the June 28th Board meeting, he presented Concept 1 as the recommend option for inclusion in the SR 68 Scenic Highway Plan, with the caveat that some widening may occur because of the approved Ferrini Ranch Development, as well as the possibility for widening between San Benancio Road and Corral De Tierra Road as a design element of the future roundabouts.

The Plan has been released for public review and will be presented to Agency Board for approval on August 23, 2017. Following adoption by the Board, the SR 68 Scenic Highway Plan will progress into the project development phase with Caltrans, followed by the Environmental Impact Review (EIR) process, and once the EIR is finalized TAMC and our partner agencies can begin a phased implementation of the Scenic Highway Plan.

Several questions followed Mr. Leonard's presentation with members asking for clarification on some of the points made, offered suggestions and expressed concerns about the "learning curve" for drivers unfamiliar with how to drive through a roundabout.

#### 4. RECEIVE INFORMATION ON THE PAVEMENT MANAGEMENT PROGRAM

Mr. Hank Myers, the Senior Transportation Planning Engineer for TAMC, explained that in accordance with the approved ordinance for the Transportation Safety & Investment Plan (Measure X), to receive Measure X funds, the cities and the County must utilize a Pavement Management Program (PMP) and submit regular reports on the conditions of their streets, to ensure timely repairs and keep the public informed.

He went on to explain that a Pavement Management Program is essentially a computer assisted method for organizing and analyzing information about pavement conditions. It is a tool that allows local agencies to assess the conditions of the roadways and determine cost effective strategies for maintaining the roadway network to get the best value for their limited dollars.

A Pavement Management Program utilizes a software-based tool such as "StreetSaver" for analyzing pavement conditions and reports findings on rehabilitation/maintenance strategies based on funding levels. The software focuses on providing cost-effective recommendations that enhance the overall system Pavement Condition Index (PCI). It provides administrators and maintenance personnel with:

- A current database inventory of roadways within a jurisdiction;
- Pavement condition tracking (PCI) for the roadways;
- A recommended project listing of all pavements needing maintenance, rehabilitation, or replacement;
- The most cost effective level of maintenance or repair appropriate at the time of the inspection;
- A forecast of budget needs for maintenance, rehabilitation or replacement of deficient pavement sections for a multi-year capital improvement program, at various overall condition levels;
- Regular reports to allow objective decision making based on data.

On a scale of 100 (excellent) to zero (failed), the statewide average PCI has deteriorated to 65 in 2016 (and was only 50 for Monterey County).

He went on to say that the Transportation Agency is assisting with the development of an overall implementation plan for this region with the participation and coordination of all the cities and the county. Nine of the thirteen agencies have provided letters of intent to participate in the joint procurement of services. The remaining four agencies are providing their own pavement management programs.

Committee members asked follow-up questions and suggested that Agency staff inquire about the public's ability to provide input to their local jurisdictions and see what projects are being conducted in their communities.

## 5. REVIEW COMMITTEE BYLAWS

The Measure X Citizen Oversight Committee Bylaws were emailed to members at the request of Chairman Dayton after the April committee meeting for their review. Debbie Hale, Executive Director of TAMC asked if committee members had any questions regarding the bylaws. Several members expressed that the bylaws were "great, short & sweet." Receiving no questions, Chair Dayton asked for a motion to approve the bylaws. The motion was made by Ms. Bumba, seconded by Mr. Schaller and unanimously approved by the committee.

Chair Dayton called for announcements and/or comments. Mr. Rowley noted that the minutes from the July meeting had been passed out to members but where not listed on the agenda for approval. Subject: Five-Year Capital Improvement Programs & Maintenance of Effort

### **RECOMMENDED ACTION:**

**RECEIVE** the Five Year Capital Improvement Program and Maintenance of Effort verification reports from the local jurisdictions as required by the Measure X funding agreement.

#### **SUMMARY:**

The Measure X funding agreement executed with each local jurisdiction required the submittal of a Five Year Capital Improvement Program outlining how the jurisdiction planned to spend its share of Measure X funds, as well as a Maintenance of Effort verification report to ensure that existing transportation spending would not be supplanted by Measure X funds.

## **FINANCIAL IMPACT:**

Measure X is estimated to generate \$600 million over the 30-year life of the program. The local share of Measure X for street maintenance and rehabilitation projects constitutes 60% of the funding, or \$12 million annually distributed to the jurisdictions based on 50% lane miles and 50% population. The purpose of the maintenance of effort requirement is to assure that jurisdictions do not shift existing funds out of transportation and backfill with new Measure X monies. Measure X funding is intended to be in addition to existing transportation spending.

#### **DISCUSSION:**

With the passage of Measure X by the voters of Monterey County, Transportation Agency staff has been working to develop the organizational frameworks and agreements necessary to implement the measure in advance of revenues being available by September 2017. As required by the implementing ordinance, each city and the County of Monterey must enter into a funding agreement with the Transportation Agency. That agreement includes enforcement procedures, designed to reassure the public that tax revenues are spent in accordance with the ballot language. As of this meeting, all of the jurisdictions have approved the agreement and final copies have been fully executed.

The expenditure of Measure X revenues by the cities or the County will be subject to verification and an annual independent audit reviewed by the Transportation Agency for Monterey County. Failure by a jurisdiction to meet any of the conditions will result in the suspension of the distribution of funds to the deficient city/county. Resumption of funding distribution to the deficient city/county will resume only after full repayment for any misuse, and confirmation of compliance with the funding agreement by the Transportation Agency for Monterey County.

In order to confirm compliance with the tax sharing agreement, each jurisdiction submitted by August 31, 2017 the Maintenance of Effort and Five Year Capital Improvement Program reports. Thereafter, the annual compliance reports listed below will be due to TAMC by December 31st of each year, starting December 31, 2018. The documents will be reviewed by Transportation Agency staff and the Citizens Oversight Committee, as well as be presented to the Transportation Agency Board.

## **REPORTS SUBMITTED BY AUGUST 31, 2017:**

- <u>Maintenance of Effort Report</u>: A report to be adopted by each jurisdiction verifying that Measure X funds received by the reporting jurisdiction have been used to augment, and not supplant, local resources spent in the fiscal year.
- <u>Measure X Five Year CIP</u>: A Capital Improvement Program looking forward for the next five (5) years that specifically references projects anticipated to be funded by Measure X.

## REPORTS DUE ANNUALLY STARTING DECEMBER 31, 2018:

- <u>Annual Program Compliance Report</u>: The Annual Program Compliance Report describes the efforts taken by the jurisdiction to comply with the requirements for the receipt and use of Measure X funds by detailing the expenditures and transportation improvements that occurred the prior fiscal year.
- <u>Annual Independent Audit</u>: The local jurisdiction shall complete an independent audit of the jurisdiction's financial statements for the prior fiscal year ended June 30th of Measure X funds received and expended.
- <u>Pavement Management Report</u>: A report on the pavement conditions of the local jurisdiction, using the standardized Pavement Condition Index.
- Maintenance of Effort: As described above. Measure X Five Year CIP: As described above.

The first Five Year Capital Improvement Program and Maintenance of Effort reports are attached for the Committee's review. Most jurisdictions' projects are focused on street repaving or reconstruction. Highlights include:

### **SUMMARY:**

The purpose of the Measure X Senior and Disabled Transportation Program is to increase transportation services for seniors and persons with disabilities to support their ability to live independently in their homes and communities. Per Measure X policies, this program is intended to fund non-profit transportation services to support seniors and persons with disabilities.

## **FINANCIAL IMPACT:**

Measure X allocates \$15 million over 30 years to this program, which is approximately \$500,000 per year. Implementation strategies were developed with the assistance from the Monterey-Salinas Transit Mobility Advisory Committee. The Mobility Advisory Committee recommends funding be available in 3 to 5 year funding cycles. Transportation Agency staff is recommending a 3-year cycle for this initial period. Approximately \$1.5 million will be available for the initial program's 3-year cycle covering fiscal years 2017/18, 2018/19 and 2019/20.

#### **DISCUSSION:**

The Senior & Disabled Transportation Services Program is part of the Regional Safety, Mobility and Walkability Measure X Programs. The purpose of this program is to increase transportation services

for seniors and persons with disabilities to support their ability to live independently in their homes and communities. Per Measure X policies, this program is intended to fund non-profit transportation services to support seniors and persons with disabilities. As spelled out in the policies and project descriptions of Measure X, the goals of this program are to:

- Give seniors more transportation options
- Support independent travel by people with disabilities
- Provide safer and more reliable senior transportation services

The **attached** draft Measure X Senior & Disabled Transportation Program: Grant Program Guidelines include program goals, funding and eligibility, application timeline and score criteria. The draft guidelines also include Measure X policies and specific program policies that apply to the the use of these funds. The Measure X policies cover maintaining a separate account for the revenues and expenditures of Measure X funds, the maintenance of effort clause, and the applicant's requirement to verify that Measure X funds were used for eligible transportation expenses only. The policies specific to this program include the ability for organizations to submit more than one application per grant cycle, the requirements for organizations selected for funding to use the Measure X logo in media releases and outreach, annual report, audit and funding agreement requirements. Additionally, organizations operating in Monterey County for at least three years can request advanced allocations for up to 50% of annual grant award amounts.

Staff has included multi-year programming of these funds and drafted a simplified application, based on input from the Mobility Advisory Committee, which serves as TAMC's Social Services Transportation Advisory Council. The TAMC Board of Directors authorized the release of the attached draft guidelines. These draft guidelines are being distributed for comment to the Mobility Advisory Committee, the eXcellent Transportation Oversight Committee, which serves as the Measure X Citizens Oversight Committee, and to other stakeholders that serve seniors and persons with disabilities.

#### Measure X

The Transportation Agency for Monterey County placed the Transportation Safety & Investment Plan (Measure X) on the November 8, 2016 ballot. and the measure was approved with 67.7% approval from Monterey County voters. Measure X is anticipated to generate an estimated \$20 million annually for a total of \$600 million over thirty years through a retail transactions and use tax of a three-eighths' of one percent (3/8%). The revenue from the sales tax measure will be used to fund transportation safety and mobility projects in Monterey County.

Based on extensive community and stakeholder input, Measure X priorities are to:

- Maintain local roads and repair potholes
- Increase safety and reduce congestion
- Improve transportation for youth, seniors, people with disabilities and working families
- Make walking and biking safer

Measure X funds are divided into two programs:

- 1. Local road maintenance, pothole repairs and safety: 60% of Measure X funds are allocated to the County of Monterey and incorporated cities for local street and road safety and maintenance improvements.
- 2. Regional safety, mobility and walkability: 40% of Measure X funds are allocated to regional safety and congestion relief, transit and bicycle/pedestrian projects.

#### **Senior & Disabled Transportation Services Program Overview**

#### **Program Purpose & Goals**

The Senior & Disabled Transportation Services Program is part of the Regional Safety, Mobility and Walkability Measure X Program. The purpose of this program is to increase transportation services for seniors and persons with disabilities to support their ability to live independently in their homes and communities.

Per Measure X policies, this program is intended to fund non-profit transportation services to support seniors and persons with disabilities.

As spelled out in the policies and projects of Measure X, the goals of this program are to:

The intent of this program is to fund projects, programs and operations that meet these goals.

#### **Stakeholders & Representatives**

#### **Funding & Eligibility**

#### **Funding**

This program funding allocation is \$15 million over 30 years, which is approximately \$500,000 per year. Implementation strategies were developed with the assistance of the Monterey-Salinas Transit Mobility Advisory Committee. The Committee recommended funding be available in 3 to 5 year funding cycles. A 3-year cycle of funding will be available for this initial period. Approximately \$1.5 million will be available for the initial program's 3-year cycle covering fiscal years 2017/18, 2018/19 and 2019/20. Funds not programmed in the current funding cycle will be carried forward and made available in future cycles.

#### **Eligible Applicants**

Measure X Senior & Disabled Mobility Program funds are available for 501(c)3 non-profit organizations that serve Monterey County residents. Organizations or collaborative projects that are not registered 501(c)3 non-profit organizations can partner with a tax-exempt, 501(c)3 non-profit organization that will serve as a fiscal sponsor for project implementation. Public agencies may be eligible if they partner with 501(c)3 non-profit organizations to complete the work included in the grant proposal.

Organizations may submit one-time or multi-year project funding requests.

#### **Eligible Activities & Expenses**

This program provides capital and operating assistance grants for projects that support mobility options for seniors and people with disabilities. Eligible activities include, but are not limited to:

- Capital projects such as:
  - Purchase or lease of accessible vehicles and vans
  - Computer hardware, software or other equipment that will support mobility programs
- Operations projects such as:
  - Operation expenses directly related to service provided to seniors and/or disabled residents of Monterey County
  - Planning, development and implementation of service area/hours expansions
  - Marketing campaigns to promote mobility services for seniors and persons with disabilities
  - Voucher, mileage reimbursement and/or other trip subsidy programs





#### **Application Timeline & Score Criteria**

#### **Application Review Process & Score Criteria**

Applications will be reviewed for completeness and assigned to a review committee for scoring. The review committee will be made up of TAMC staff, representatives from the MST Mobility Advisory Committee and the eXcellent Transportation Oversight Committee. The review committee will review and rank the applications based on the following criteria:

- **1. Applicant experience:** Organization has demonstrated knowledge experience serving seniors and/or people with disabilities.
- 20 points
- Applicant has experience providing social services for seniors and/or people with disabilities:
  - o More than 5 years: 10 points
  - 3 5 years: 7 points
  - 1 3 years: 5 points
  - 2 3 years: 3 points
  - 1 2 years: **2 points**
  - Less than 1 year: 1 point
- Applicant has experience providing transportation services for seniors and/or people with disabilities:
  - More than 5 years: 10 points
  - 3 5 years: 7 points
  - 1 3 years: **5 points**
  - 2 3 years: 3 points
  - 1 2 years: **2 points**
  - o Less than 1 year: 1 point





**2. Project feasibility and readiness:** Project readiness for implementation and ability to implement the project within the 3-year funding timeline.

20 points

- Project is ready for implementation within 3 months of funding award, and has a reasonable schedule for implementation: 20 points
- Project will be ready for implementation within 6 months of funding award, and has a reasonable schedule for implementation: 15 points

#### **Policies**

#### **Transportation Safety & Investment Plan Policies**

The following policies apply to projects funded by this Measure X Senior and Disabled Transportation Program:

- Transportation Safety & Investment Plan Account: For ease of tracking and to assure full
  transparency, all revenues received and expenditures of these funds will be accounted for and
  tracked in its own separate account titled "Transportation Safety & Investment Plan Account"
  and will not be comingled with any other funds.
- Eligibility Verification: Under no circumstances may the proceeds of this transportation sales tax be applied to any purpose other than for transportation projects, programs and activities. Awarded applicants will certify in an annual verification submitted to TAMC that these transportation funds were used for eligible expenses.
- Maintaining Local Transportation Funding Efforts: Measure X funds cannot supplant other funds that are currently committed to the applicant's project.





#### Measure X Senior and Disabled Transportation Program Specific Policies

The following policies apply specifically to this Measure X Senior and Disabled Transportation Program:

- **Multiple applications:** Organizations can submit more than one application per grant cycle reflecting different operational or capital needs.
- **Funding Agreement:** Organizations selected for funding must sign a funding agreement with TAMC.
- **Annual Report:** Organizations selected for funding must provide an annual report documenting communities served and success meeting project goals and proposed outcomes
- Audits: TAMC reserves the right to audit organizations that are awarded funding under this
  project.
- Media Releases: Organizations selected for funding must use the Measure X logo when
  promoting projects, programs or services funded by this Measure X program and acknowledge
  the Measure X program in news releases.
- Project Payments: Once funds are allocated to an approved project, the project sponsor has three years to expend the funds. Capital project expenses may be invoiced directly to TAMC and must include documentation of competitive procurement solicitation process with a minimum of 3 bids and the vendor invoice. Operating project expenses may be claimed in advanced to cover estimated operating expenses for that quarter. Invoiced costs are to be on a quarterly basis and must comply with Measure X Transportation Safety & Investment Plan policies. Each claim following the first claim for payment must include documentation (procurement solicitation process if applicable, receipts, vendor invoices, and progress reports) to be deemed valid. The Transportation Agency Measure X Senior and Disabled Transportation Program Project Manager, Finance Officer, and Executive Director will review and recommend approval or rejection of the claims.

#### **RECOMMENDED ACTION:**

**RECEIVE** the draft 2017 Measure X Strategic Expenditure Plan.

#### **SUMMARY:**

The Polices and Project Descriptions document for Measure X calls for the Transportation Agency to prepare and adopt by a vote of the Transportation Agency Board a Strategic Expenditure Plan within twelve months of the sales tax taking effect. The expenditure plan is to include project cost estimates, revenue estimates, other matching funds, and a draft timeline for regional project delivery.

#### **FINANCIAL IMPACT:**

Measure X is estimated to generate \$600 million over the 30-year life of the program, with an estimated \$8 million dedicated to regional projects annually. To expedite project delivery, the draft expenditure plan assumes debt financing against the regional portion of Measure X.

#### **DISCUSSION:**

The Policies and Project Descriptions for Measure X identified which projects and programs will receive Measure X revenue, and the amounts they will receive, but not the dates they will receive these funds. Recognizing that not all \$600 million in projects can be delivered at the outset of the program, the Measure X Polices and Project Descriptions document requires that the Transportation Agency for Monterey County adopt a Strategic Plan that prioritizes the projects and establishes a timeline for their implementation within twelve months of the sales tax taking effect.

Staff considered five guiding principles in the development of the draft Strategic Expenditure Plan:

- Assure that the overall Measure X program of projects is delivered
- Maximize leveraging of Measure X revenue

- Control project and program costs
- Accelerate project delivery through financing, where appropriate
- Coordinate with Caltrans and Project Sponsors to complete pre-construction phases of regional projects as early in the program as feasible.

In order to determine the timing of funding for the regional projects, the Strategic Plan establishes the relative priority among the projects contained in the Measure X Transportation Safety & Investment Plan. This is a more complex task than appears on the surface since many of the Measure X projects rely upon some other funding sources for implementation. Additionally, only some of the improvements funded from Measure X represent regional projects, while others are categorical programs such as "Safe Routes to School" and transit programs. The largest component in Measure X however is the fixed percentage of sales tax revenue used to fund Local Road Maintenance. This latter category of allocated funds will flow directly to the designated recipients and as such does not require prioritization.

The prioritization criteria used to rank the regional projects were derived from the Policies and Project Descriptions document as well as from input from the Transportation Agency Board of Directors, and are as follows:

- 1. Project Readiness
- 2. Ability to Leverage Matching Funds
- 3. Fair Geographic Distribution of Funds
- 4. Project Need: Congestion Relief and Safety Benefits
- 5. Cost Effectiveness & System Connectivity

With the projects rated, staff developed a cash flow model to determine the cost and schedule for the regional projects in Measure X, and identify possible financing tools needed to deliver the regional program. Based on this draft analysis and the over-arching goal of delivering projects as early in the Measure X program as necessary, staff included a round of potential debt financing in the first five years of the program. The use of debt financing and what mechanism could potentially be used (bonds, loans, etc.) will be determined at a later date, however the initial analysis confirms that a significant portion of the regional program could be completed within the first five years. The following four projects could start construction within the next five years, assuming the successful receipt of matching funds:

- State Route 68 Safety & Traffic Flow
- Marina-Salinas Multimodal Corridor
- Fort Ord Regional Trail and Greenway
- Holman Highway 68 CHOMP Roundabout

At the September Board of Directors meeting, Agency staff received guidance from the Board on the list of projects and priorities. Agency staff then reviewed and received comments on the draft funding plan from the Technical Advisory and Executive Committees before bringing the proposal forward to the Board of Directors for review and comment at the October 25th meeting. The Transportation

Agency Board is scheduled to adopt the final plan at their December meeting.

#### 1. Executive Summary

#### **Background**

Starting in May of 2015, the Transportation Agency engaged in a public outreach effort to inform the public about our transportation needs, funding challenges and the self-help option. The Transportation Agency for Monterey County placed the Transportation Safety & Investment Plan (Measure X) on the November 8, 2016 ballot and the measure was approved with 67.7% approval from Monterey County voters. The measure is anticipated to generate an estimated \$20 million annually for a total of \$600 million over thirty years through a retail transactions and use tax of a three-eighths' of one-percent (3/8%). The revenue from Measure X funds critical safety, mobility, and maintenance projects and programs in three categories:

- \$360 million (60%) to Local Road Maintenance, Pothole Repairs & Safety
- \$160 million (27%) to Regional Road Safety & Congestion Improvements
- \$80 million (13%) to Pedestrian & Bike Safety and Mobility Projects

#### Sales Tax Revenues

As noted above and described in more detail in Chapter 4, Measure X sales tax revenues estimated in the 2016 Transportation Safety and Investment Plan were forecast in constant dollars and estimated to be \$600 million through March 31, 2047. However, given economic activity in Monterey County since the time Measure X was being developed, the Transportation Agency has assumed a beginning sales tax revenue value of \$24,839,186 for Fiscal Year 2017-2018. From this base year amount, the Transportation Agency forecasts future revenues. As historic Monterey County taxable sales data serves as a proxy for sales tax revenues, the Transportation Agency's financial consultant, KNN Public Finance, recommends that the Measure X sales tax revenue forecast assume a long-term average growth rate of 3.21 percent. This information is incorporated into the cash flow model provided in Chapter 9.

#### **Project Prioritization**

One of the purposes of the Strategic Plan is to establish the relative priority among the projects contained in the Measure X Transportation Safety & Investment Plan as far as the sequence in which they will be implemented. The eight projects that will be prioritized using the criteria provided by the Transportation Agency Board of Directors are:

- Highway 68 Safety & Traffic Flow
- US 101 Safety Improvements South County
- State Route 156 Safety Improvements
- Marina-Salinas Multimodal Corridor (Imjin Safety & Traffic Flow)
- Highway 1 Rapid Bus Corridor
- Holman Highway 68 Safety & Traffic Flow A (Community Hospital of the Monterey Peninsula Roundabout)
- Holman Highway 68 Safety & Traffic Flow B (Pacific Grove Complete Streets)
- Fort Ord Regional Trail and Greenway

Measure X regional projects are prioritized for programming based on five key criteria as recommended by the Transportation Agency Board of Directors and identified in the Measure X Policies and Project Descriptions document. A rating of High (green), Medium (yellow), and Low (red) is used for each criterion to evaluate the projects. Presented as a summary here, the full project prioritization and supporting documentation can be found in Chapter 3.

#### First Five Years

The 2017 Measure X Strategic Expenditure Plan is a five-year planning document, coordinated with the 2018 State Transportation Improvement Program cycle. To manage the various available funding sources with eligible Measure X projects, Chapter 4 presents the five-year integrated funding plan, which incorporates the results of the project prioritization to identify projects that can start construction in the first five years of Measure X. Those projects expected to start construction are:

- State Route 68 Safety & Traffic Flow
- Marina-Salinas Multimodal Corridor (Imjin Safety & Traffic Flow)
- Fort Ord Regional Trail and Greenway
- Holman Highway 68 CHOMP Roundabout

#### Accelerating Project Delivery through Financing

Many sales tax programs, such as Measure D in Santa Barbara County, successfully implement a debt financing strategy in order to expedite the delivery of the regional program of projects. On a "pay as you go" basis, it can become more difficult to deliver the program within the thirty-year life of the sales tax due to construction cost escalation and fluctuating sales tax revenues. In the case of Measure X, issuing bonds or other debt financing instruments may be necessary primarily to ensure sufficient cash flow to deliver regional projects as they become ready for construction.

The cash flow model presented in Chapter 9 shows sales tax revenues exceeding authority-wide annual debt service at around 2.0x or better. In addition, fiscal year 2016-2017 unaudited data shows a significant increase in sales tax revenues over initial projections during the development of Measure X. These metrics suggest that there is additional debt capacity on an authority-wide basis. This debt capacity, however, may be only available to projects in the regional program. Should the Transportation Agency not be able to fund projects for the regional program on a pay-as-you-go basis or through inter-program loans then bond financing could be an option to ensure that project expenditures are funded.

To this end, Transportation Agency staff has conducted an extensive debt financing review with the Agency's financial consultants, KNN Public Finance, to determine potential debt financing strategies to include in the cash flow model. The initial cash flow model presented in Chapter 9 includes \$37 million of debt financing within the first five years of the program, which will require further study and approval by the Transportation Agency Board of Directors.

#### Local Road Maintenance & Pay-As-You-Go Programs

Pay-as-you-go financing involves paying for capital expenditures with available cash on hand and, as such, no debt is incurred under pay-as-you-go financing.

Pay-as-you-go financing by Measure X is used for the apportionments to the Habitat Preservation / Advance Mitigation, Safe Routes to Schools, Senior and Disabled Transportation, the Commuter Bus, Salinas Valley Transit Centers and Vanpools programs, and the Local Road Maintenance fund.

The Local Road Maintenance funds are allocated quarterly to all Monterey County jurisdictions. The formula distribution for these funds is based on 50% road miles and 50% population. The formula is updated as new information becomes available using Department of Finance population figures and center line miles as reported by the California Department of Transportation.

#### Strategic Expenditure Plan Updates

The Strategic Expenditure Plan is a five-year programming document. It provides a snapshot of anticipated cash flow, as well as a commitment of funds to specific projects for the next five years of Measure X. In order to effectively reflect upon actual revenues and project progression, this plan sets a goal for updates every two years.
