During this period the State Board of Equalization has collected and remitted \$19,317,757.56 to the Monterey County Measure X fund 554 and the fund has earned \$10,284.51 of interest. During this period initial and onetime fees of \$829,418.76, TAMC administrative costs of \$166,150.88, Regional Project costs of \$89,173.46 and County and Cities 60% share of \$10,857,526.61 were disbursed.

#### 1. <u>WELCOME</u>

Kevin Dayton, Committee Chair, called the meeting to order at 2:02. Chair Dayton proceed by asking each member to introduce themselves and for Theresa Wright, TAMC's community outreach coordinator, to use their introductions as a roll call, by noting who was present on the sign-in sheet. Chair Dayton also asked members of the public and TAMC staff to introduce themselves.

#### 2. PUBLIC COMMENT

Chair Dayton called for public comment. Receiving none, he proceeded to item 3.1 of the consent agenda seeking the committee's approval of the draft minutes of the October 17, 2017 eXcellent Citizens Oversight Committee.

#### 3. <u>APPROVE THE MEASURE X CONSENT AGENDA</u>

Chair Dayton called for a motion to approve the draft minutes of the October 17, 2017 Oversight committee minutes. The motion was made, seconded and passed unanimously. With no other items on the consent agenda, Chair Dayton proceeded to items on the regular agenda.

#### 4. RECEIVE A CALL FOR NOMINATIONS AND ELECT COMMITTEE OFFICERS

Theresa Wright, TAMC's community outreach coordinator announced that the committee needed to call for the nomination and election of officers to serve as Chair and Vice Chair of the Measure X Citizens Oversight Committee. Elected officers term would begin upon their election through the next election of officers at the beginning of the January 2019 meeting. Chair Dayton called for the nominations. Motions were made to nominate Kevin Dayton to serve as Chair and for Anthony Tomas Rocha to serve as Vice Chair. Both motions were seconded and passed unanimously.

#### 5. PRESENTATION OF THE 2017 5-YEAR INTEGRATED FUNDING PLAN

Mike Zeller, Principal Transportation Planner, presented the final 2017 5-Year Integrated Funding Plan. The Plan identifies projects that are strong candidates for specific Senate Bill 1 grants, State Transportation Improvement Programs funds, Measure X, and other matching funds, and can be brought to construction over the next five years.

The presentation was followed by discussion with committee members asking about SB1 and the efforts to repeal the gas tax. Committee members stressed it is important for the Agency to communicate the importance of the "gas tax" to the public and its impact, not only on Measure X projects, but to the additional funding that each jurisdiction would receive to make improvements within their own cities.

They noted that not including the amount that would go to the individual cities/county, in the next five years the \$90 million of Measure X funds and \$54.05 million in the State Transportation Improvement Program funds could be matched with over \$221 million in Senate Bill 1 grants and other funding programs for regional projects in Monterey County.

## 6. RECEIVE PRESENTATION AND PROVIDE INPUT ON THE DRAFT MEASURE X SAFE ROUTES TO SCHOOL PROGRAM GUIDELINES

Ariana Green, Associate Transportation Planner, presented the draft Measure X Safe Routes to Schools Program Guidelines and asked the committee to provide input on the guidelines. The presentation of the proposed guidelines set forth a vision and identified goals, objectives and types of projects and programs that could be funded through the program.

A robust discussion followed with members asking about the criteria for setting priorities, leveraging funds for the program, and stressing the importance of education to foster a cultural shift. At the conclusion, Chair Dayton requested that the committee receive regular updates on the progress of the program.

## 7. RECOMMEND THE TAMC BOARD PROGRAM \$1.5 MILLION OF MEASURE X FUNDS FOR THE SENIOR & DISABLED TRANSPORTATION PROGRAM OF PROJECTS

Virginia Murillo, Transportation Planner, asked the committee to recommend that the TAMC Board of Directors program \$1.5 million of Measure X funds for the Senior & Disabled Transportation Program. The program of projects recommended for funding are:

- The Veterans Transition Center of California-Mobility Opportunities for Veterans -\$258,689
- Blind and Visually Impaired Center-Orientation and Mobility Training -\$178, 550
- Josephine Kernes Memorial Pool-Kernes Pool Transportation Voucher Program -\$147,000
- Alliance on Aging-Senior Transportation Specialist Project -\$170,000
- ITN Monterey County-Dignified Transportation of Seniors and Visually Impaired Adults \$745,761

These recommendations were made by the grant review committee comprised of members from the Oversight Committee and the Monterey-Salinas Transit Mobility Advisory Committee.

After the presentation, member Bumba who served on the review committee asked that the staff report be revised to correctly reflect the reason the review committee recommended a reduction of ITN Monterey County's request.

After noting the correction, the committee approved the motion to recommend that the TAMC Board of Directors program \$1.5 million of Measure X funds for the Senior & Disabled Transportation Program.

#### 8. <u>ANNOUNCEMENTS AND/OR COMMENTS</u>

Chair Dayton called for announcements and/or comments.

Theresa Wright, Community Outreach Coordinator, stated that she had received a request from committee member Getzelman asking if one or two of the meetings could be held in Salinas. Her request was made in consideration of the long distance that representatives from Lockwood and Bradley travel to attend the meetings.

Receiving no objections to the request from the committee, Ms. Wright was tasked with exploring locations to hold one or two of the remaining committee meetings in Salinas.

Ms. Wright also announced that the next X-TOC meeting will be on April 17, 2018 at the Marina Public Library.

#### 9. ADJOURMENT

Chair Dayton adjourned the meeting at 3:20 p.m.

#### **RECOMMENDED ACTION:**

**RECEIVE** and **ACCEPT** a status report on the Measure X Transportation Safety and Investment Plan receipts and disbursements for the first nine months of the program, from April 1, 2017 to December 31, 2017.

#### **SUMMARY:**

During this period the State Board of Equalization has collected and remitted \$19,317,757.56 to the Monterey County Measure X fund 554 and the fund has earned \$10,284.51 of interest. During this period initial and onetime fees of \$829,418.76, TAMC administrative costs of \$166,150.88, Regional Project costs of \$89,173.46 and County and Cities 60% share of \$10,857,526.61 were disbursed.

#### FINANCIAL IMPACT:

The receipts of \$19,317,757.56 for the first nine months far exceeds the original estimate of \$15,000,000.00. Some upfront costs were incurred such as for the election, State BOE Implementation, attorney work for agreements and pavement management implementation. Revenues are distributed to the cities and the County on a quarterly basis; three quarterly distributions totaling \$10,857,526.61 have been made to the to the cities and the County. The allocation formula for the city county shares is calculated using a formula based on 50% lane miles and 50% population.

#### **RECOMMENDED ACTION:**

**RECEIVE** update on local agency Measure X funded projects.

#### **SUMMARY:**

In the first nine months, Measure X has generated over \$18 million for transportation projects and programs. The cities and county receive 60% of the Measure X funding, and they are putting their money to work on local construction projects.

#### **FINANCIAL IMPACT:**

A total of almost \$11 million of the available Measure X revenue is allocated to local agencies' projects. In several cases, this locally generated funding will leverage other grant funds, such as state gas taxes, to fully fund projects. The remaining total of about \$7 million of the available Measure X revenue is allocated to regional and mobility projects.

#### **DISCUSSION:**

Construction has started on transportation projects and programs utilizing funds generated by Measure X. Some of the construction work got off to an early start and has already been completed. Other city and county Measure X projects are in the pipeline and are scheduled for bidding and construction later this summer and fall. The Measure X funding has provided the opportunity for local agencies to move forward with key roadway improvements in their communities that may have otherwise been deferred many years.

Having a reliable funding source allows agencies to develop a variety of strategies to construct the needed roadway improvements. Some agencies have adopted a funding strategy to maximize their funding by leveraging the Measure X funds. This could mean using the funds to match grant applications or using the funds to leverage a local bond measure. Some agencies with smaller

allocations may need to save up their allocations to generate enough revenue to fully fund a project at a future date. Other agencies have projects that are in the planning pipeline and will be implemented after the completion of environmental or design phases or after they secure additional grant funding.

Local roadway repairs and safety were identified as a Measure X priority, with 60% of the funding allocated to this category. A key element of determining the best strategies for deciding what roads to repair is to utilize a Pavement Management Program. It is a requirement of Measure X that each local agency develop a Pavement Management Program and submit regular reports on the conditions of their roads in order to receive funding. The Agency goal is to have all twelve cities and the County utilizing the "StreetSaver" software for pavement condition reporting by the end of this year. The software will help each agency get the most value for their limited paving dollars.

#### **RECOMMENDED ACTION:**

**RECEIVE** report on audit process and **ACCEPT** the Transportation Safety and Investment Plan (Measure X) audit report for fiscal year ending June 30, 2017.

#### **SUMMARY:**

The auditors found no instances of noncompliance that are required to be reported under Government Auditing Standards, nor did they note any matters involving the internal control over financial reporting and its operation that they consider to be material weaknesses.

#### **FINANCIAL IMPACT:**

The auditors did not charge for the report in FY 16-17, as the ordinance was only in effect for April, May and June 2017. The total funds and interest collected during the audit reporting period was \$4,942,342. Payouts and expenditures made during the audit period were \$3,334,281. The Transportation Safety and Investment Plan has a fund balance of \$1,608,061 as of June 30, 2017.

#### **DISCUSSION:**

The Transportation Agency has fiduciary responsibility for the administration of the Transportation Safety and Investment Plan (Measure X) funds. Ordinance 2016-01 was passed by 67.7% of the Monterey County voters in November 2016 and started being collected effective April 1, 2017.

Measure X, is anticipated to generate an estimated \$20 million annually, for a total of \$600 million over thirty years. The funding source is a retail transactions and use tax of 3/8 cents. The revenue from the sales tax measure can only be used to fund transportation safety and mobility projects in Monterey County. The trust fund's administrative costs are paid for by the Transportation Agency for Monterey County and then reimbursed to the Agency as specified in the Measure X documents.

Based on extensive community and stakeholder input, the Measure X plan established priorities to:

- Maintain local roads and repair potholes
- Increase safety and reduce congestion
- Improve transportation for youth, seniors, people with disabilities and working families
- Make walking and biking safer

Measure X funds are divided into two programs:

- 1. Local road maintenance, pothole repairs and safety: 60% of Measure X funds are allocated to the County of Monterey and incorporated cities for local street and road safety and maintenance improvements.
- 2. Regional safety, mobility and walkability: 40% of Measure X funds are allocated to regional safety and congestion relief, transit and bicycle/pedestrian projects and expended on projects as prioritized in the Strategic Expenditure Plan.

The purpose of the audit is to confirm that the Transportation Agency for Monterey County complied with Ordinance 2016-01-Transportation Safety and Investment Plan, that the financial statements are free of material misstatement and assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

Moss, Levy & Hartzheim, Certified Public Accountants, completed the audit for fiscal year ending June 30, 2017. The auditors found no instances of noncompliance that are required to be reported under Government Auditing Standards, nor did they note any matters involving the internal control over financial reporting and its operation that they consider to be material weaknesses.

We have performed certain procedures which were agreed to by the Transportation Agency for Monterey County (TAMC), solely to assist it in evaluating management's assertion that the Transportation Agency for Monterey County complied with Ordinance 2016-1 - Monterey County Transportation Safety and Investment Plan of the Transportation Agency for Monterey County. We have also performed certain procedures solely to assist it in evaluating management's assertion that the cities of Carmel, Del Rey Oaks, Gonzales, Greenfield, King City, Marina, Monterey, Pacific Grove, Salinas, Sand City, Seaside, and Soledad, and the County of Monterey complied with the Maintenance of Effort requirement, and the Alternative Transportation Investment Plan requirement, for the fiscal year ended June 30, 2017. Management of each of the entities listed above is responsible for compliance with Ordinance 2016-1 of the Transportation Agency for Monterey County including, for the cities and the county, the Maintenance of Effort requirement and the Transportation Safety and Investment Plan requirements. This agreed-upon procedures engagement was performed in accordance with attestation standards established by the American Institute of Certified Public Accountants.

Difficulties Encountered in Performing the Engagement

We encountered no significant difficulties in dealing with management in performing and completing our engagement.

#### Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the engagement, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of engagement procedures and corrected by management were material, either individually or in the aggregate, to each opinion unit's financial statements taken as a whole.

#### Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting or reporting matter, whether or not resolved to our satisfaction, that could be significant to the financial statements. We are pleased to report that no such disagreements arose during the course of our engagement.

#### Other Findings or Issues

In planning and performing our engagement we performed certain procedures agreed upon by TAMC. Documented below are the results and findings of our agreed upon procedures:

• Confirmed that the expenditures of revenues, for all receiving entities, is in accordance with the Transportation Safety and Investment Plan.

**Result**: During our testing of expenditures we did not find any material expenditures that did not comply with the Ordinance 2016-1.

 Verification that Measure X funds and interest earned are deposited in a separate account (fund) for all receiving entities.

**Result**: During our examination of the accounting records of the recipients of Measure X funding, it was noted that the Measure X funds were deposited in a separate Transportation Safety & Investment Plan Account and that the interest was properly allocated and retained in that fund.

 Validation that no more than one percent of Measure X revenues is used for TAMC administrative staff salaries and benefits.

**Result**: During our compliance testing of Measure X allocations, it was noted that no more than one percent of revenues were used for administrative staff salaries and benefits.

Verification that Measure X revenues were split with 60% dedicated to local road maintenance, porthole repairs
and safety projects, and 40% dedicated to regional safety and mobility projects.

**Result**: During our compliance testing of Measure X revenue allocations, it was noted that the proper split of revenues was maintained.

• The entities' compliance with Maintenance of Effort.

**Result**: Compliance procedures cannot be completed because as of June 30, 2017, no funding had yet been distributed to any of the entities listed on the prior page.

#### Other Matters

With respect to the supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with accounting principles generally accepted in the United States of America, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to the financial statements of the Transportation Agency for Monterey County for the fiscal year ended June 30, 2017. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves. The financial statements are publicly available at the offices of the Transportation Agency for Monterey County at 55-B Plaza Circle, Salinas, California 93901-2902 and posted online at http://www.tamcmonterey.org.

**Subject:** Senior & Disabled Transportation Grant Program

#### **RECOMMENDED ACTION:**

**RECEIVE** presentation on the Measure X Senior & Disabled Program competitive grants process, awards and next steps.

#### **SUMMARY:**

The Transportation Agency approved a call for applications for the first cycle of Measure X Senior and Disabled Transportation Program competitive grants at the October 2017 meeting, and made awards at the January 2018 meeting. Public comment received at the February 28, 2018 Transportation Agency Board of Directors questioned the geographic equity of the first round of Measure X Senior and Disable Transportation grant awards. Staff will present an overview of the grant process, application review, awards and the next steps for program implementation.

#### **FINANCIAL IMPACT:**

This cycle of grants programs \$1.5 million of Measure X funds for a 3-year cycle covering fiscal years 2017/18, 2018/19 and 2019/20.

#### **DISCUSSION:**

The Senior & Disabled Transportation Services Program is part of the Regional Safety, Mobility and Walkability Measure X Program. The purpose of this program is to increase transportation services for seniors and persons with disabilities to support their ability to live independently in their homes and communities. Per Measure X policies, this program is intended to fund non-profit transportation services to support seniors and persons with disabilities.

As spelled out in the policies and project descriptions of Measure X, the goals of this program are to:

- Give seniors more transportation options
- Support independent travel by people with disabilities

• Provide safer and more reliable senior transportation services

The Senior & Disabled Program Grant Guidelines were presented to this Committee and the MST Mobility Advisory Committee for comment. The TAMC Board of Directors approved the guidelines, and issued a call for projects at the October 2017 meeting. Staff conducted outreach to notify prospective non-profits about the availability of funds at meetings of the MST Mobility Advisory Committee, and at meetings of the South County Outreach Efforts group. Applications were due on December 1, 2017, and TAMC received five eligible applications.

The grant application was comprised of five sections with a total of 90 points possible. The five sections and corresponding score criteria were designed and approved by the Transportation Agency Board to favor projects and programs that will meet the transportation needs of seniors and people with disabilities throughout Monterey County. Below is a summary of the application sections and corresponding score criteria. The guidelines and score sheet with detailed criteria is included as a **web attachment.**

In October and November 2017, the eXcellent Transportation Oversight Committee and the Monterey-Salinas Transit Mobility Advisory Committee nominated committee members to the grants review committee:

The Transportation Agency received five completed grant applications, totaling \$1.7 million in requested Measure X Senior & Disabled Transportation Program grant funding. Each application was reviewed and scored by the review committee. **Attachment 1** provides an overview of projects and their score averages by the review committee.

- The Veterans Transition Center of California Mobility Opportunities for Veterans \$258,689
- Blind and Visually Impaired Center Orientation and Mobility Training \$178,550
- Josephine Kernes Memorial Pool Kernes Pool Transportation Voucher Program \$147,000
- Alliance on Aging Senior Transportation Specialist Project \$170,000
- ITN Monterey County Dignified Transportation of Seniors and Visually Impaired Adults \$745,761

Following public comment at the February 28 TAMC Board of Directors meeting, the TAMC Executive Committee met to discuss issues of geographic equity in this first round of grant funding. The Executive Committee directed staff to conduct a needs assessment and identify ways to improve the program for the next call for projects.

MST through the Measure Q Investment Plan and the Association of Monterey Bay Area Governments through the Transportation Alternatives for Rural Areas Study have done a significant amount of work to identify transportation services that are needed in South County and other rural areas of the County. TAMC staff will confer with South County leaders to identify strategies to meet South County's transportation needs. Staff will continue to coordinate with the MST Mobility Advisory Committee to identify gaps in services. That Committee also has membership of service providers that serve South County and have a unique insight as to their needs. The process for the next call for projects will begin in Fall/Winter 2019.

WHEREAS, the Measure X Citizens Oversight Committee and the Monterey-Salinas Transit Mobility Advisory Committee nominated committee members to serve on the Measure X Senior and Disabled Transportation Program Grants Review Committee, which evaluated and scored each of the Grants applications received from the jurisdictions; and

**WHEREAS**, the Measure X Citizens Oversight Committee have recommended approval of the Measure X Senior and Disabled Transportation Program of Projects, which is attached hereto as Attachment 1 and incorporated fully by this reference; and

**WHEREAS**, the projects in Attachment 1 that are recommended to receive Measure X funds are in compliance with the Transportation Safety and Investment Plan Ordinance.

#### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Board of Directors of the Transportation Agency for Monterey County hereby adopts, authorizes and approves the 2017 Measure X Senior and Disabled Transportation Program of Projects for Fiscal Years 2017/18 through 2019/20 as identified in Attachment 1 in accordance with this Resolution; and
