*The Agency released a Request for Qualifications for the public-private partnership financial services in September 2014. Three statements of qualifications were received. Ernst & Young Infrastructure Advisors was the highest ranked firm with extensive experience supporting public agencies in the public private partnership process.*

*The Agency's current agreement for right-of-way acquisition services expires December 31, 2014. Staff is seeking to extend the existing contract with Overland, Pacific, and Cutler for three months and release a Request for Qualifications to select a firm to continue with acquisition services for the Kick Start phase of the Salinas Rail Extension project.*
